

PRISONER: Dr WEST, Karl, Rudolf Werner German plenipotentiary in Denmark

1. PERSONAL DATA

Dr BEST was born in DARMSTADT, 10 Jul 03. He attended elementary school from 1909 until 1921 in LIEGNITZ, DORTMUND and MAINZ. He studied law from 1921 until 1925 at the University of FRANKFURT, FREIBURG and GIESSEN, and served as Referendar in Hessian courts and law firms from 1925 until 1928. He obtained his law degree at the University of HEIDELBERG in 1928. 1929-1931 Worked in Hessian courts.

1930	Joined NSDAP
1930	Married Hilde REGNER
1931	Elected member of the Hessian Landrat, joined SS. Relieved from duty with the Hessian courts because of his political activities.
1931-1933	NSDAP Kreisleiter of MAINZ
1933	Regierungstat and head of the police department of the Hessian Ministry of Interior: (Isrdespolizaipraesident). Relieved from duty late in 1933 because of conflict with
1934	Gauleiter SPRENGER. Employed with the SD and Gestapo in STUTT- GART & MUENCHEN in an advisory capacity on legal matters.
1935-1940	Chief of Gestapo department for justice and jurisprudence.
1939 1940-1942	Enlisted in Army. Recalled from the Army and placed in charge of judicial section of the "Verwaltungs-
19`42	stab" of the Wehrmacht in France. Ministerial Direktor in the Auswaertige Amt.
1942-1945	Reichs plenipotentiary to Denmark, at first not accredited but later functioning as a regular envoy to the Danish government. (As such his functions were of a purely palitical nature) Interned since 21 May 45.

COPENHAGEN on 21 May 45, immediately after the German surrender. The following reports have been published on the basis of his interrogation by British and Danish agencies.

4. INTERROGATION PLAN

In view of the fact that BEST was very thoroughly interrogated by both Danish and British authorities, no further interrogation is planned unless special briefs are received.

5. COMMENTS AND RECOMMENDATIONS

BEST mainly active in a political field and his knowledge of German intelligence is but scanty. He should be returned to Danish authorities for further action. No FIR will be published.

Recipients of this report are requested to submit special briefs for interrogation of prisoner, and to indicate desired distribution of the resultant report.
